In order to Register, tuition payment for the first and last month (May) and the non-refundable Registration Fee is required to reserve a place in class. Tuition payment is due at the first lesson of each month. Payments are considered late if not received at the studio by the 10th of the month. A \$15.00 Late Fee is charged for payments received after the 10th of the month. Statements will be sent out for delinquent accounts only. Returned check fee is \$25.00. Students are required to purchase and wear the appropriate Studio leotard for the class they are assigned. Dancewear is available at the Studio. The Recital Fee and Recital Costume Fee are non-refundable. \$15.00 fee is charged for costume and recital fee payment received after the due date. Recital costumes become the property of the student. NO REFUNDS are granted for classes not attended, regardless of reason. Classes missed due to illness may be made up within four weeks. Alpharetta Dance Theatre is not responsible for missed classes due to inclement weather. If a student withdraws, prior to Sept 1st, the studio will retain one month's tuition. After the first class, a written notice is required one month in advance of withdrawal. Students may not withdraw mid month; withdrawal notice must be dated and received by the Director by the 1st of the month. Reduction of class hours requires a written notice one-month in advance. Students withdrawing will be billed for class until 30 day past receipt of written notice regardless of attendance. No liability is assumed by Alpharetta Dance Theatre, Inc. or its staff for the purpose of the student for accidents by acts of said student or students and the person signing agreement on behalf of said student assumes full responsibility. Registration taken by phone is considered a signed agreement. Students are to be dropped off no more than 15 minutes prior to class and are to be picked up ON TIME after class is over; a \$15 fee will be added to your tuition if your child is not picked up on time.
