

**DRIVING DIRECTIONS TO DERMATOLOGY ASSOCIATES OF WISCONSIN

From Sturgeon Bay, Door County or Kewaunee

- Take Hwy 42 south into the City of Two Rivers
- Continue on Hwy 42 through the city.
- Hwy 42 will then become Waldo Blvd in Manitowoc
- Take Waldo Blvd and turn south (left) on Rapids Rd. (CTH R)
- Follow Rapids Rd. and turn west (right) on Expo Dr.
- Turn south (left) off of Expo Dr. onto Randolph Ct. (1st left hand turn off of Expo Dr)
- Follow Randolph Court to the cul-de-sac to our office

From Green Bay, Upper Michigan or Wausau

- Take I43 south and turn east (left) onto Hwy 151 (exit #149)
- Follow Hwy 151 and turn north (left) onto CTH R (Rapids Rd.)
- Follow CTH R to Expo Dr. and turn west (left)
- Once on Expo Dr., turn south (left) onto Randolph Ct. (1st left hand turn off of Expo Dr)
- Follow Randolph Court to the cul-de-sac to our office

From Menasha or Appleton:

- Take Hwy 10 east to I43
- Take I43 south to exit #149 (Hwy 151)
- Turn left (east) onto Hwy 151
- Follow Hwy 151 to South Rapids Rd (2nd stop and go light)
- Turn left (north)
- Follow S Rapids Rd to Expo Dr., turn left (west)
- Take first left off of Expo Dr. onto Randolph Ct.
- Follow Randolph Court to the end – 1515 Randolph Court

From Oshkosh to Neenah:

- Take Hwy 41 north to Hwy 441 east
- Take the Oneida Street exit and turn right
- Follow to Hwy 10 and turn left
- Take Hwy 10 east to I43
- Take I43 south to exit #149 (Hwy 151)
- Follow Hwy 151 to South Rapids Rd (2nd stop and go light)
- Turn left (north)
- Follow S Rapids Rd to Expo Dr., turn left (west)
- Take first left off of Expo Dr. onto Randolph Ct.
- Follow Randolph Court to the end – 1515 Randolph Court

From Sheboygan or Milwaukee

- Take I43 north and exit on Hwy 151 (exit #149)
- Go east (right) at off ramp
- Continue on Hwy 151 (Calumet Ave.) and turn north on Rapids Rd. (CTH R)
- Follow Rapids Rd. to Expo Dr. turn west (left)
- Turn south (left) off of Expo Dr. onto Randolph Ct. (1st left hand turn off of Expo Dr)
- Follow Randolph Court to the cul-de-sac to our office

From Valders, Chilton or Fond du Lac

- Follow Hwy 151 east and turn north (left) onto CTH R (Rapids Rd.)
- Follow CTH R to Expo Dr. and turn west (left)
- Once on Expo Dr., turn south (left) onto Randolph Ct. (1st left hand turn off of Expo Dr)
- Follow Randolph Court to the cul-de-sac to our office
